WICASA of Vapi Branch Elections – (2015-2016)

The Managing Committee of Vapi Branch of WICASA shall be composed of 6 persons elected by the members of the Vapi Branch of WICASA from amongst its members. Some of the relevant rules regarding eligibility to vote, eligibility to contest for election, mode of filling nomination etc., are given below:

1. Any student, who is a member of Vapi Branch of WICASA as on 31st March, 2015 is eligible to vote in the election. For this purpose, any student undergoing articleship training within the Territory of VAPI Branch of WIRC of ICAI will be considered as members of Vapi Branch of WICASA.
2. Any member eligible to vote in the election can contest for in the election provided the unexpired period of his/her articleship training as on 1st April, 2015 is not less than one year.
3. A member desiring to contest the election shall submit a nomination form duly signed by himself and by a Proposer and a Seconder, who shall be persons entitled to vote in the election. The Nomination form will be available at ICAI Bhawan, Vapi from 23rd March, 2015 during office hours as well as on www.vapi-icai.org.
4. List of valid nominations will be display at ICAI Bhawan, Vapi on 31st March, 2015 by 11 am and the last date and time for withdrawal of nomination will be 2nd April, 2015 2 pm.
5. The final list of Nomination will be displayed at ICAI Bhawan, Vapi on 3rd April, 2015 by 11 am.
6. If required, the election shall be by way of poll of members on 4th April, 2015 at "ICAI BHAVAN, Vapi".
7. The names of all candidates elected shall be announced at the meeting by the Election Officer and his decision and declaration shall be final.
8. Members are requested to bring along their identity card and copy of letter of articleship registration as proof of their eligibility to vote.

9. A nominee is also required to submit a copy of his letter of articleship registration alongwith his nomination form briefly describing his **Vision Statement** (as in provided in Nomination Form).

10. The Eligibility form is to be duly filled and attested by members principal in case he / she is not able to produce Articleship Registration Letter or Articleship ID card issued by ICAI.

11. The Election officer has right to reject the ANY FORMS which are incomplete or not having properly filled up or it does not contain relevant information asked for.

11. CA. Chirag Shah has been appointed as Election Officer and appointed to receive, scrutinize, finalize the nominations and to conduct the election in accordance to manner prescribed in Appendix No. 5 of Chartered Accountants Regulations, 1988.
